## Personal Guaranty for Business Credit Account

I/We agree that The Perennial Farm, may, without notice and without reducing my/our liability under this Guaranty: (i) enter into future transactions with the Company; (ii) modify the terms of any credit agreements; (iii) extend extra time or more credit to the Company or Guarantor; and (iv) settle, release, or assign any rights with respect to any debt owed to The Perennial Farm by: (1) the Company, (2) myself/ourselves or (3) any other guarantor of the Company. I/we agree to be bound by the current Terms and Conditions of The Perennial Farm as posted at [www.perennialfarm.com](http://www.perennialfarm.com), which may be amended from time to time.
